Protect Bill Buster Competition 2025 - Terms & Conditions

1. Introduction

- 1.3 By participating in this Competition, Entrants agree to be bound by these Terms and Conditions.
- 1.4 Entrants' personal information will be collected, used, and disclosed in accordance with the Promoter's Privacy Policy.

2. Eligibility

- 2.1 To be eligible to enter the Competition, Entrants must:
 - (a) be an Australian or New Zealand resident aged 18 years or older;
 - (b) be a current member of Protect;
 - (c) download and log in to the Protect App;
 - (d) enter the Competition and adhere to the entry requirements; and
 - (e) comply with these Terms and Conditions.
- 2.2 Current or former Board members, employees, or immediate family of the Promoter are ineligible to enter.

3. Competition Period

3.1 The Competition commences at **12:01 AM on 7 April 2025** and closes at **11:59 PM on 5 October 2025.** All times are in AEST (Melbourne time).

4. How to Enter

- (a) download the Protect App from the App Store or Google Play;
- (b) log in to the Protect App with member credentials that include a Protect membership number (or verified email address) and password;
- (c) enter the Competition via the feedback option on the Protect App during the Competition Period; and
- (d) provide requested information, including name, Protect membership number, email address, and country, state, or territory of residence.

5. Prizes
